Regional Goals:

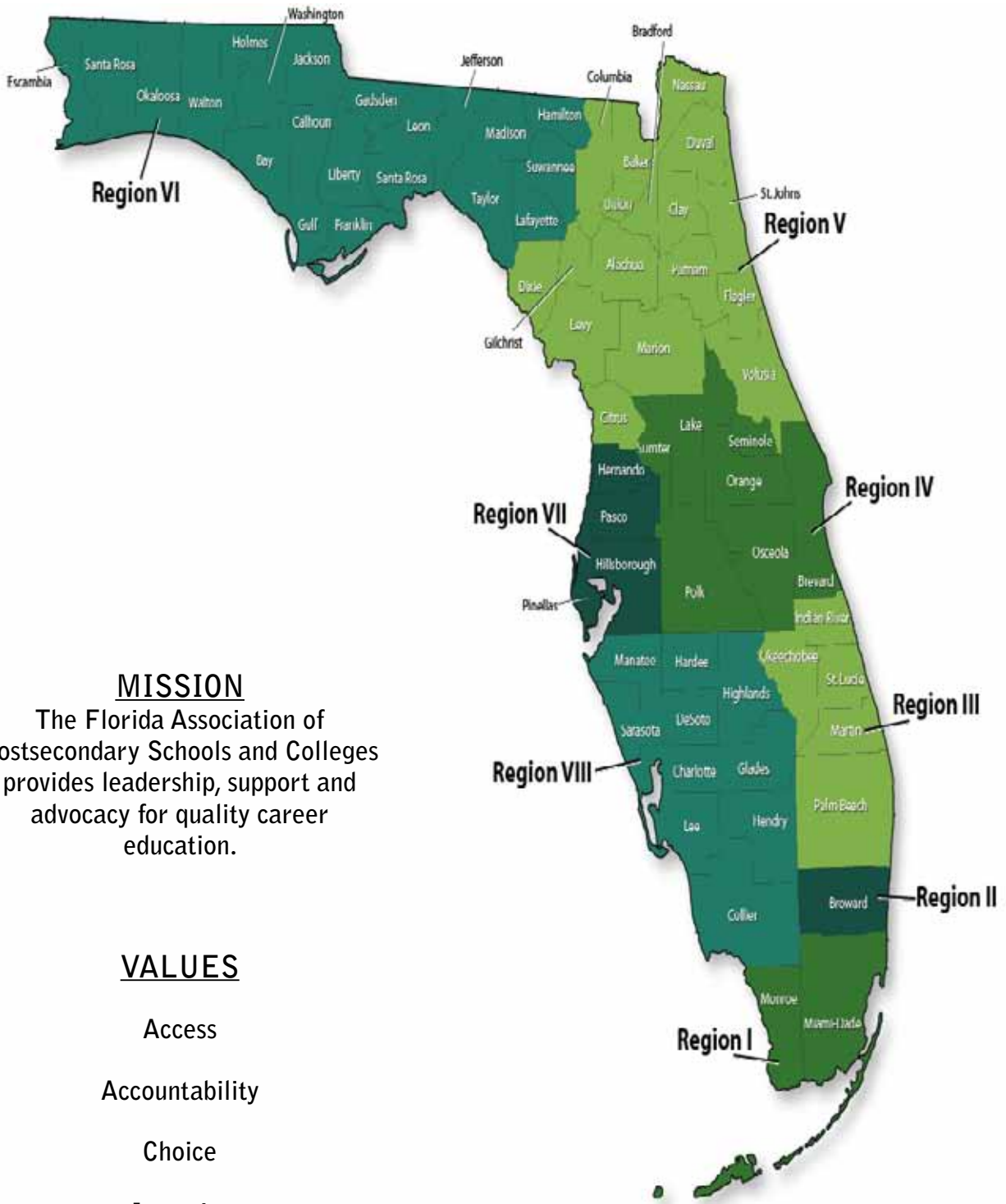
1. Establish a calendar for regional meetings

1. Invite member and non-member schools in your region to a meet and greet with your local Workforce Board chair.
2. Call one non-member school a week and ask why they haven't joined FAPSC and how we can earn their membership.
3. Ask to make a brief presentation at the local workforce board, chamber of commerce meeting, etc., to inform business people about our schools and programs.
4. CIE Staff are often out on site visits. Arrange a meet or greet for member and non-member schools.
